2017 EXPO OUTCOMES

LEGISLATION & RULINGS AFFECTING EXCAVATORS

- 2016 LEGISLATION THAT REQUIRES ONE-CALL PARTICIPATION BY MUNICIPALITIES
 - MUNICIPALITIES OWNING/OPERATING UNDERGROUND FACILITIES MUST JOIN THE ONE-CALL AND MUST LOCATE THEIR LINES WITHIN 48 HOURS OF NOTIFICATION – EFFECTIVE 11/1/2016
- 2017 LEGISLATION THAT MAY AFFECT OKIE811
 - HB-1376 ADDRESSING THE DEFINITION OF PUBLIC AGENCIES IN THE UNDERGROUND DAMAGE PREVENTION ACT (REMOVING POSSIBLE EXEMPTIONS FOR COUNTY, CITY, STATE WORKERS & THEIR CONTRACTORS)
- PHMSA RULING ON STATE ENFORCEMENT ADEQUACY
 - EXCAVATORS WILL BE SUBJECT TO FINES AND PENALTIES WHEN THERE IS A PIPELINE DAMAGE
 - PHMSA MAY ENFORCE FINES AND PENALTIES IF THE STATE ENFORCEMENT IS INADEQUATE
 - PHMSA WILL REQUIRE LEGISLATION FOR STATES FAILING ADEQUACY CRITERIA
 - EVALUATION OF STATE ADEQUACY WILL OCCUR ANNUALLY

 - WILDLAND FIRES & FIRE BREAKS

- OKPERI – OKLAHOMA PIPELINE EMERGENCY RESPONSE INITIATIVE

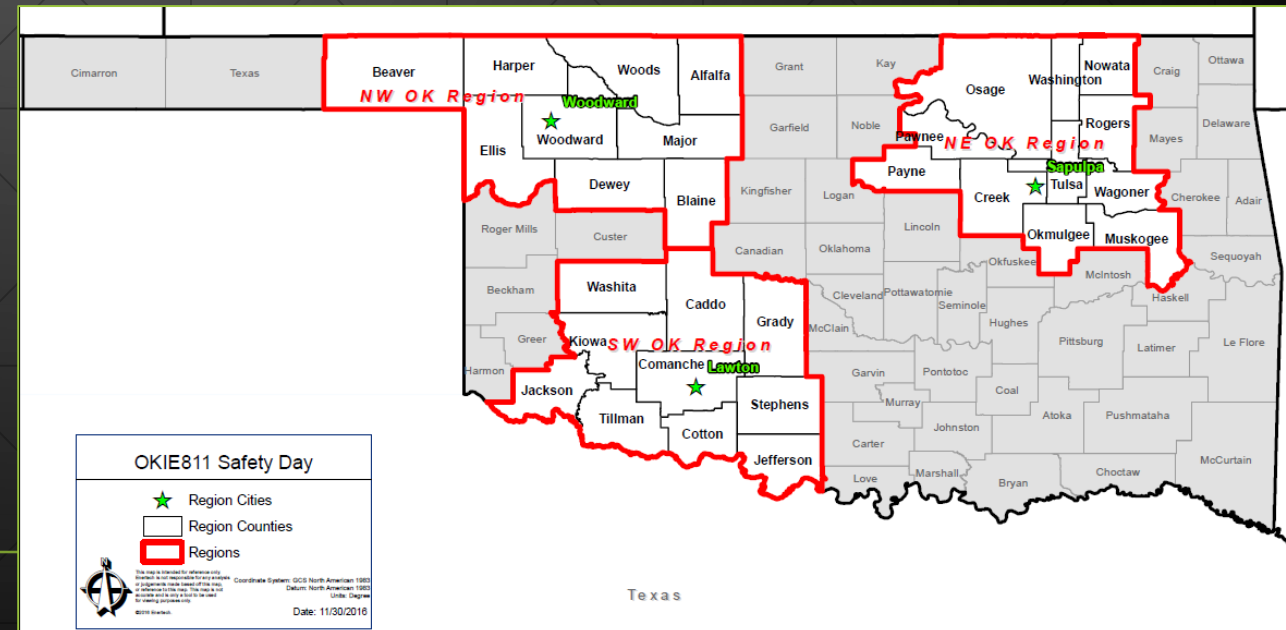
